Regarding the palm oil used, BC scheme is used to maintain the coverage of certification. Credits are purchased based on the expected annual usage, and its shortfall will be satisfied after the annual usage is confirmed. The number of annual palm oil usage can differ from that of purchased RSPO Credits because of the interval between the palm oil usage and the Credits purchase. We are planning to switch to MB model and aiming for a physical usage rate of certified palm oil of 100% by FY 2028.
