During 2024 we were using only certified palm oil for all our production. However, there were still finished products on stock (for all markets except Germany and Romania) which had no certified palm oil from previous productions in 2023, so we were not able to communicate those SKUs as MB on invoices, even though they did contain MB certified palm oil. The stock of such non-MB SKUs was cleared in October 2024 and since then all SKUs are marked as MB on invoices. Products for Germany and Romania used only MB certified palm oil and had no non-MB products on stock, so quantity for those markets had MB certified communication on all 2024 invoices. Palm oil certified according to the SG model was purchased in December 2024 and used in production in January 2025.
