We purchase RSPO credits to cover our gap in certified uptake. Most of the gap came from 1 new item where the first delivery was not RSPO, but all subsequent deliveries were certified. We do not expect the gap to be so large in the future. SSL continues to be difficult for us to source as RSPO. Our uptake slightly decreased due to retooling of one of our production lines which reduced our production capacity.
